

GINO'S PIZZA® SUMMER GIVEAWAY

OFFICIAL PROMOTIONAL RULES

NO PURCHASE NECESSARY

1. CONTEST PERIOD

The Gino's Pizza® Summer Giveaway (the "Promotion") begins at 12:00:01 a.m. Eastern Time ("ET") on Friday, June 19, 2026 and ends at 11:59:59 p.m. ET on Monday, August 31, 2026 (the "Contest Period"). The Promotion is brought to you by Gino's Pizza® (the "Contest Sponsor"). The Contest Period may be amended — either shortened or lengthened — at the sole discretion of the Contest Sponsor without prior notice.

2. ELIGIBILITY

This Promotion is open only to legal residents of the Province of Ontario who have reached the age of majority (18 years) in their province of residence as of the start of the Contest Period. Employees, agents and representatives of the Contest Sponsor and of Porter Airlines, together with their respective parent companies, affiliates, licensors, associates, subsidiaries, franchisees, and advertising and promotional agencies, and the persons with whom any of them are domiciled, are not eligible to enter or to win. The Promotion is void where prohibited by law.

3. HOW TO ENTER

- a. There are two (2) easy ways to enter during the Contest Period:
 1. **Option 1 — Purchase the Summer Special:** Place an online order that includes the Gino's Summer Special (2 Medium Pizzas with 2 toppings each, 8 Wings, 4 500 ml Drinks and 4 Dipping Sauces) for \$44.99 (plus applicable taxes) and you will be automatically entered into the Promotion.
 2. **Option 2 — Add a 4-Pack of Pop:** Add a 4-pack of Pop (4 × 500 ml) for \$5.99 (plus applicable taxes) to any online order and you will be automatically entered into the Promotion.
- b. **No Purchase Necessary:** To enter without making a purchase, print your full name, complete mailing address, email address and phone number on a 3" × 8" piece of white paper and mail it to: Gino's Pizza® Summer Giveaway Promotion, Promotional Department, 25 Brownridge Road, Halton Hills, Ontario L7G 0C6. All No Purchase Necessary entries must be postmarked no later than August 24, 2026 and received at the above address no later than 4:00 p.m. ET on August 28, 2026. Limit one (1) No Purchase Necessary entry per person, per envelope, with sufficient postage. Entries sent in business reply envelopes will NOT be honoured. Eligible No Purchase Necessary entries are entered into the same random draw as all eligible online entries.
- c. Unless otherwise stated by the Sponsor, each eligible online transaction that includes one or more qualifying offers will receive one entry into the Promotion.
- d. Orders placed by phone, in-store, through third-party delivery platforms, or through any non-participating channel are not eligible unless expressly stated by the Sponsor.

4. ENTRIES & VERIFICATION

- a. Each qualifying online order constitutes one (1) entry. There is no limit to the number of online entries a person may earn through separate qualifying orders placed during the Contest Period.
- b. All entries become the property of the Contest Sponsor. The Contest Sponsor reserves the right, in its sole discretion, to verify the eligibility of any entrant and to disqualify any person who tampers with or abuses any aspect of the Promotion, who enters by means not authorized by these rules, or who acts in a manner the Contest Sponsor considers to be in violation of these rules or unfair to other entrants.
- c. The Sponsor is not responsible for lost, late, delayed, misdirected, incomplete, illegible, damaged, or postage-due mail, or for any technical, website, ordering, database, communication, or other error that affects entry into the Promotion.

5. ODDS OF WINNING

- a. Odds of winning depend on the total number of eligible entries received during the Contest Period — including eligible online orders and eligible No Purchase Necessary entries — that fulfil the criteria set out in Section 3 (How to Enter).

Grand Prize details: The Grand Prize is a round trip for four (4) persons departing from a designated Porter Airlines gateway airport in Ontario to a scheduled Porter Airlines destination. The approximate retail value of the Grand Prize is up to \$5,000 CAD, depending on destination, travel dates, routing, and availability. The Grand Prize includes round-trip airfare only. - a. Within five (5) business days after the close of the Contest Period, the Contest Sponsor will randomly select potential winners for each prize from among all eligible entries in the database.

No less than four (4) separate attempts will be made to contact each selected potential winner — two (2) by telephone and two (2) by email — using the contact information associated with the entry. If a selected potential winner cannot be reached within five business days of the first contact attempt, declines the prize, fails to meet any requirement of these rules, or fails to correctly answer the skill-testing question, that person will be disqualified and the Contest Sponsor may, in its sole discretion, select an alternate potential winner from the remaining eligible entries.

8. SKILL-TESTING QUESTION & DECLARATION

- a. Before being declared a winner, each selected potential winner must (a) correctly answer, without assistance, mechanical, or other aid, a time-limited mathematical skill-testing question; and (b) sign and return a fully completed Declaration confirming understanding of, acceptance of, and compliance with these Promotional Rules, together with a Release of Liability and a Publicity Release satisfactory to the Contest Sponsor.
- b. Failure to sign and return the required documentation within the timeframe specified by the Sponsor will result in forfeiture of the prize.

9. PRIZE CONDITIONS

Selected winners will have six (6) months from the close of the Contest Period to claim and book their prize, and one (1) year from the close of the Contest Period to use any travel or voucher components of a prize. To help ensure availability, travel must be booked at least five (5) months before the intended departure date.

Approximate retail values of technology and travel prizes are estimated as at the date these rules are posted and may change based on market conditions; any difference between the stated value and the actual value will not be awarded. All prizes must be accepted as awarded, are non-transferable, and have no cash surrender value.
- c. The Contest Sponsor reserves the right, in its sole discretion, to substitute any prize (or any component of a prize) with one of equal or greater value in the event a prize becomes unavailable for any reason.
